4. In case scores are same for more than one candidate, the ranking has been done on the basis of sectional scores, considered in the order of Quantitative Techniques & Data Interpretation, Logical Reasoning, Language Comprehension, General Awareness.

5. Candidates having same Score are listed in a chronological (ascending) order as per their date of

birth.

6. Candidates having same score have been given the same Merit, and the next Merit rank has been increased by the same number i.e. if there are two candidates at Merit 2, Merit 3 would not be awarded to the next candidate but Merit 4 would be given.

7. The admission authorities are advised to use NTA score awarded to the students for allotment of seat in the AICTE approved programmes along with the other criteria that may exist, as applicable.


8. Candidate's particulars including Category and Person with Disability (PwD) have been indicated as mentioned by the candidate in the online Application Form.

3. This **Provisional Engagement** is subject to satisfactory verification of the prescribed educational qualification, community certificate and other certificates, wherever prescribed. The candidate will have to undergo satisfactory prescribed Induction Training course and Practical Training as and when issued.

4. The engagement is provisional and subject to certificates being verified through proper channels. If the verification reveals that the claim of the candidate belonging to Scheduled Caste/Scheduled Tribe /Other backward classes/(not belong to creamy layer)/ is false or educational certificates are not genuine or found unfit on Police Verification, his/her

Engagement shall be terminated forthwith without assigning any further reasons and without prejudice to other criminal/legal action as may be taken under the provisions of Indian Penal Code for production of false certificate as a consequence.

5. The engagement of (Economically Weaker Sections) EWS candidates is provisional and is subject to the Income and Asset certificate being verified through proper channels and if the verification reveals that the claim to belong to EWS is fake/false the Engagements will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of fake/false certificate.

6. At the time of joining, you will have to give undertaking on bond paper of Rs.100/- that, you have adequate independent means of livelihood for yourself and your family and other than the TRCA(allowances) being paid to you by Govt.

7 The BPM will have to provide accommodation for Branch Post Office at Branch Office Village if the accommodation is not provided by Central Govt/State Govt/Gram Panchayat or any other local Body as per standard prescribed by Directorate order no.17-31/2016-GDS dated 25.06.2018 notification mentioned in 28.09.2018 (which has already been & STC/12-GDSONLINE/2020 DATED 01.09.2020 As per Rule 3-A(vii) of GDS (Conduct and Engagement) Rules 2020, you should take up residence in Post Office village within a month of selection but before engagement as it is mandatory to you by these Rules. Failure to reside in place of duty for GDS BPM after engagement shall be treated aa violation of conditions of engagements and liable for disciplinary action under Rule-10 of GDS (Conduct and Engagement) Rules, 2020 resulting in removal/dismissal from engagement.

7.1 Failure to reside within the delivery jurisdiction of the Post Office for other categories of Gramin Dak Sevaks after engagement shall be treated as violate of conditions of engagement and liable for disciplinary action under Rule 10 of the GDS (Conduct& Engagement) Rules, 2020 requiring removal/dismissal.

8. At present DARPAN devices are using Network Service Providers(NSPs) viz, Airtel, Voda-Idea & BSNL etc. for ensuring connectivity to Branch Post Offices. While providing accommodation for GDS BO, it should be ensured that, Network is available for any one of these NSPs.

9. You will have to furnish requisite Security Bond of Rs.1,00,000/- (Rs. One lakhs only) for five years by remitting requisite premium per annum and application in prescribed form to concerned Postal Co-Operative Society through Drawing and Disbursing Officer.

10. You will have to furnish declaration for having knowledge of cycling. If you are having knowledge of riding a scooter or motor cycle, that may be considered as knowledge of cycling. The candidate has to submit a declaration to this effect and has to produce driving license.

11. If any information or documents submitted by the candidates is found false / incorrect at a later stage, his/her engagement shall be terminated in accordance with Rule 8 of GDS (Conduct & Engagement) Rules, 2020.





Management Aptitude Test and Test Scores

- 1 The Management Aptitude Test (MAT) is designed to measure the aptitude of a candidate for pursuing management education and should be used only for this purpose.
- 2 MAT is administered in five sections-Language Comprehension, Mathematical Skills, Data Analysis & Sufficiency, Intelligence & Critical Reasoning and Indian & Global Environment-each section testing a different ability relevant for management education.
- 3 All MAT administrations necessarily have different questions. Thus one administration may be slightly more difficult or less difficult than another. Scaling has been used to take care of these differences.
- 4 The scaled scores reported are standardised scores for respective sections. These scores are reported on a scale of 0 to 100. Extreme scores (below 15 or above 85) are rare.
- 5 The percentile below column indicates the percentage of candidates in the test who scored below that of the candidate in the section.
- 6 The Composite score is an overall scaled score based on the first four sections of MAT. This is reported on a scale of 199 to 801.
- 7 The percentile below for the Composite Score represents the percentage of candidates whose composite scores are below the candidate's. The composite score has a validity period of one year.
- 8 All scores and percentile below figures are reported after rounding off to the nearest whole number.
- 9 Personal data is as reported by the candidate.
