
Respected Sir,





REPORT OF INDISCIPLINE BEHAVIOUR

On 9th May 2018, the department received a call from the Principal-in-charge regarding involvement of Sujith Prakash G of II B.Com. P.A. - B in lifting of Mobile Phones from students' bags at corridors on 09.05.2018 during University Semester Examination. During the process of enquiry with Sujith, he mentioned Palanivel R of II B.Com. P.A. - B (Sujith Prakash's close friend). To probe on it, Palanivel R too was instructed to report the enquiry committee.

At 3.45 pm, breaking the restriction for entry into staffroom, he intensely came into the staffroom at 'D' Block Ground Floor and started behaving with the members of faculty in an unruly manner. The faculty felt threatened and unsafe. Besides instruction, he refused to move out of the staffroom.

The situation was informed to the Principal-in-charge and Discipline Committee members over phone. They reported the spot immediately and tried to handle the situation. But even during their course of enquiry, the student behaved rashly and disrespectfully thus breaking the decorum of teacher-student relationship.
