REPORT OF INDISCIPLINE BEHAVIOUR

On 9th May 2018, the department received a call from the Principal-in-charge regarding involvement of Sujith Prakash G of II B.Com. P.A. - B in lifting of Mobile Phones ash from students' bags at corridors on 09.05.2018 during University Semester nation. During the process of enquiry with Sujith, he mentioned Palanivel R of II an. P.A. - B (Sujith Prakash's close friend). To probe on it, Panivel R too was instructed eport the enquiry committee.

At 3.45 pm, breaking the restriction for entry into staffroom, he intensely came into the staffroom at 'D' Block Ground Floor and started behaving with the members of faculty in an unruly manner. The faculty felt threatened and unsafe. Besides instruction, he refused to move out of the staffroom.
