

With reference to your application for the National fellowship for Persons with Disabilities, I am pleased to inform you that based on the recommendations of the Expert Committee; UGC has selected you for the National Fellowship for Persons with Disabilities for the year 2020-21.

2. 3.	Contingency (For Sciences and Engineering & Technology)	@ Rs. 12,000/- per annum for initial two years. @ Rs. 25,000/- per annum for remaining three years.
4.	Escorts / Reader Assistance	@ Rs. 2,000/- per month in cases of candidates with physical and visual disabilities.
5.	HRA	As per UGC pattern.

4. The candidate must get himself/herself registered for M.Phil/Ph.D at the first available opportunity but not later than **within a period of two years** from the receipt of award letter and this period is not extendable. However, the actual payment of fellowship will be made with effect from 01.04.2020 (or) from the date of Registration under M.Phil. / Ph.D. (or) from the date of joining in M.Phil./Ph.D. programme, **whichever is later**.

5. It may be noted that the fellowship amount shall be disbursed through Canara Bank to the bank branch account of the awardee, (any bank). The awardee is required to approach the designated branch of Canara bank along with a copy of the award Letter and Joining Report with Photograph, address and contact no. in the prescribed proforma **Annexure - II**.







If she desires to leave the Institution, one month notice should be given for getting relief, failing which one month salary should be remitted in lieu of short notice.




